*Sherie Catledge of Bear Country Retrievers.***

Sherie Catledge will be here July 27<sup>nd</sup>, 28<sup>th</sup> and 29<sup>th</sup> 2023 to host a personalized handlers workshop. This workshop will be to help YOU and your dog become a better handling team. All breeds that are allowed to enter AKC Hunt Tests are eligible and all levels of experience are welcome!!

Sherie is an AKC Hunt Test judge. She has been judging all levels of AKC since 1998 and judged Master at the GRCA National Specialty in 2015 and 2019. As an experienced trainer Sherie knows what it is like to be the person at the line. As a judge, a handler, a dog trainer and an excellent handling coach, her insights are invaluable.

If we have true beginners, each day will begin with basic instruction for beginning dogs and their handlers. The rest of the day will focus on drills for all levels of work based on what was requested by the working teams. Each day will end with a Q&A discussion. The workshop is intended to give a new handler the skills to move forward training their dog for a GRCA Working Certificate or AKC Junior Hunter or for a more experienced handler to improve their handling and training skills to progress their dogs through Master or HRC Finished.

Workshop Schedule: Thursday July 27, check-in at 9:00 am. Workshop runs 9 am to 5 pm; Friday July 28 Workshop runs from 9 am to 5 pm; and Saturday July 29 Workshop runs from 9 am to 4 pm.

The MHGRC WC/WCX will be held at Horsetooth Retriever Kennels on Sunday July 30. This event is limited to Golden Retrievers, Flat-coated Retrievers, NS Duck Tolling Retrievers, and Labrador Retrievers. It is a titling event for Golden and Flat-coated Retrievers. Sherie will be available for Private Lessons on Wednesday July 26. Seven lessons will be available at \$50 per lesson on a first come first serve basis starting at 10:30 am.
