CANADIAN EXHIBITORS MUST SUBMIT ENTRIES WITH CHECKS DRAWN ON U.S. ACCOUNTS OR WITH INTERNATIONAL MONEY ORDERS IN U.S. FUNDS.

Entry fee will not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judge or barred from competition by action of the Show Committee.

Entry fee will be refunded for Bitches in Season. This must be communicated to Show Secretary minimum of 30 minutes prior to the start of the trial. No email notification the day of the show. Notice for a bitch in season delivered on the day of the show must be hand delivered to the show secretary. (Exhibitor note: if you are not in attendance anyone/ exhibitor can write a request, sign as your agent and deliver to the show secretary on site.)

Entry fee will be refunded if these events are canceled due to Covid-19 restrictions being modified.

Withdrawal due to injury or illness after the closing date is eligible for a 50% voucher for entry at future MHGRC events provided a veterinarian's letter attesting to the nature of the injury is provided within one week of the show. In such instances the secretary MUST be notified by e-mail no later than 24 hours before the start of the show. False reports warrant refusal of entries at future MHGRC events. Any other withdrawals after the closing date will not be eligible for refund.

Post Dated Checks & Returned Checks do not constitute a valid entry fee. The Show Secretary will add a \$50.00 collection fee to the amount of each returned check. Subsequent returned checks from the same exhibitors may result in their being put on a CASH ONLY basis.

No entry fees will be refunded if the Show cannot open or be completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an Act of God, public emergency, act of a public enemy, strikes and/or any other cause beyond the control of the Club or the Show Secretary.

No entry shall be made and no entry shall be accepted which specifies any condition as to its acceptance. Changes, additions or corrections to entry forms must be received in writing or email (NO TEXT) prior to close of entries. Owners are responsible for errors in making out entry forms, whoever may make such errors, and no entry fee will be refunded in event of such errors or cancellation of entries after the published closing date.

## **SHOW SITE INFORMATION:**

These trials will be held indoors on an arena dirt floor.

Saturday Show Hours 7:00 am to 6:00 pm. Sunday Show Hours 7:00 am to 4:00 pm.

Dogs and equipment must be removed from the show site immediately following the presentation of all “High” Obedience and Rally Awards on Sunday.

The show grounds constitute the building & the outside grounds and parking areas.

All regulations governing the use of this facility, and all regulations and decisions of the Event Committee of this show giving club on this day will be strictly enforced, including those not recorded in this Premium List.

Exhibitors and handlers will be held responsible for clean conditions in and around their crates and set up area. Exhibitors are responsible for cleaning up after their own dogs AT ALL TIMES.

NO dogs will be allowed in the restrooms.

Unentered dogs may be required to leave the show building by the Event Committee.

Parents are solely responsible for their children and are expected to keep them supervised and under control at all times; for their own safety. No baby strollers are allowed in the show buildings.

### **EXHIBITOR INFORMATION:**

A Recording Fee of 50 cents for each dog, an AKC Event Service Fee of \$3.00 for the first entry of each dog and an AKC Event Service Fee of \$3.50 for each additional entry of the same dog will be required for each recordable single entry class at any Licensed or Member Club Show or Obedience Trial. An AKC Recording fee of \$3.50 for each entry will be required for each dog in Rally. (American Kennel Club Rally Regulation, Chapter 1, Section 4) These Fees are paid to the American Kennel Club. These AKC fees are to be collected by the show giving club and paid to the American Kennel Club. These fees are included in the entry fee charged by the club.

Dogs need be present only for scheduled judging and will be released if not needed for further judging. Dogs must be ready for judging. Neither the Club nor its Show Secretary will be responsible or obligated to furnish any service for notifying exhibitors or their agents of Class Judging. Judges need not wait for any dog holding up a class. Owners or agents alone are responsible for the presence of their dogs in the judging rings.

The show giving Club, the Show Secretary, their agents, employees, etc. assume no responsibility for any loss, damage or injury sustained by exhibitors, handlers, or to any of their dogs or property while at or on the show grounds, or in transit to or from the show and further more assumes no responsibility for injury to children.

The hosting club will exercise every precaution for the safety of dogs exhibited, but it must be understood that neither the club, site or show secretary will be responsible for any injury, damage, or loss. It is understood that all dogs at this show are in the care and custody of the owners or owner's agents during the entire show weekend.

No double handling will be permitted at these shows. Individuals who attempt to double handle from outside the ring will be subject to action by the Event Committee.

There shall be no drilling or intensive /abusive training of dogs on the show grounds.

Dogs must be under control at all times. This includes the use of Flexi leashes.


Exhibitors are required to clean up after the dogs that they are exhibiting; or those which are under their care or control.
